**Instructions for Principal Investigators:**

The Material is experimental in nature and must be used with prudence and appropriate caution, since not all of its characteristics are known. **THE MATERIAL IS PROVIDED WITHOUT WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR ANY OTHER WARRANTY, EXPRESS OR IMPLIED.** Except to the extent prohibited by law, RECIPIENT assumes all liability for damages, which may arise from RECIPIENT's use, storage or disposal of the Material. Neither CSU nor JHU (including, but not limited to, their directors, trustees, officers, employees, students, and agents, as applicable) will be liable to RECIPIENT for any loss, claim or demand made by any other party, due to or arising from RECIPIENT's use of the Material. **The material shall not be used for any Commercial Purpose or for work on human subjects, including diagnostic testing.** "Commercial Purpose" means the sale, lease, license or other transfer of the Material or modifications to a for-profit company to perform contract research, to screen compound libraries, to produce or manufacture products for general sale, or to conduct research activities that result in any of the above activities. Sponsored research shall not constitute a Commercial Purpose under this MTA without the occurrence of one or more of the other events. Should the use of this material result in one or more scientific publication(s), you shall acknowledge in the publication(s) that the material was provided to CSU by the JHU and the JHU Investigator identified above. The Material may only be distributed to any other party (for-profit or non-profit) for research purposes and pursuant to the Uniform Biological Materials Transfer Agreement ("UBMTA") or under other agreements at least as restrictive and protective of JHU's and the U.S. government's rights as the UBMTA. The RECIPIENT agrees that Materials are or may be subject to patent, patent application, license or other proprietary protection and any commercial use thereof requires a license from JHU. Requests from commercial entities shall be subject to the above conditions, including the agreement by such commercial entity that any Commercial use of Materials may require a license from JHU and an agreement with CSU to seek from JHU such a license. The Material will be provided at no cost to RECIPIENT and storage and dissemination by CSU will be provided under the NIAID Grant at no cost to JHU. This MTA is not assignable and may not be modified without the express written permission of the parties and and JHU and may be terminated for any reason effective thirty (30) days from written notice of CSU's intention to terminate.
